Social Security Act was signed by President Franklin D Roosevelt on August 8 1935. Taxes were collected for the first time in January 1937 and the first one-time, lump-sum payments were made that same month. Regular ongoing monthly benefits started in January 1940. #### **National Lodge Update**

The timing on this Newsletter deadline is not opportune for more detailed information from the National FOP. We will hold our next online National Board of Directors meeting in five days. I will provide any important information that is relayed by the National Lodge at that December 16 board meeting by email to members.



Certainly, since my last report in October the most important information is that the candidate we supported for president was elected. The FOP enjoys a very special relationship with President-elect Trump and looks forward to working closely with him for the next 4 years! We are already having input on decisions that he is making for his upcoming term.

The most important item that the National FOP and State and Local Lodges have been working on these last several months is the Social Security Fairness Act. We did get this legislation passed by the House and it is now in the Senate. On the day that I am writing this article the Fraternal Order of Police, International Association of Fire Fighters and other unions held a rally in Washington DC to urge the Senate to pass this legislation. Senate Leader Chuck Schumer addressed the rally and pledged to move the bill to the Senate floor for a vote. It is expected that the bill will be voted on by the Senate on December 13.

We should know the result by the time this newsletter is published. This has been a high priority for the National FOP for many years and this is certainly the closest we have come to get it passed. Most officers in North Carolina are not adversely affected by the current way Social Security is handled but it is estimated that as many as 60% of officers in the country are affected. Let's hope that this injustice is corrected this year. President Biden has indicated he would sign the legislation into law if it gets to his desk.

The National Lodge has now obtained insurance for members that volunteer for assistance to our DART team. This insurance is being provided by Berkley Accident and Health Company. More information will be provided on this insurance in the future.

Lodges are reminded that they should be now making plans for delegates to attend the 2025 Biennial National FOP Conference in Miami Beach August 3-8. National leaders and FOP policy will be decided at that conference for the next 2 years. Making plans now will help your lodge to send some delegates to participate in these important decisions.

Lodges also need to plan now to attend the National Memorial Service in Washington in May. Reservations for Police Week are now available on line at <u>WWW.PoliceWeekHotelRooms.com</u>. Please send some of your members to honor those officers that paid the ultimate sacrifice in serving their country.

Western North Carolina is still trying to recover from the tremendous damage that resulted from Hurricane Helene. All members are reminded that I chair the National Disaster Relief Committee that is part of our National Foundation. FOP members are eligible for payments when they suffer a disaster that affects their homes. The application is available at FOP.NET. The requirements are they must be a member, own their home, have substantial damage to the home itself and be displaced for some period of time. All grants are for \$500 to help the member that is displaced with immediate needs. Our NC FOP Foundation also offers a \$500

grant to members that suffer a covered disaster. Contact our State Foundation to file for that grant.

#### Scholarship for Children of Permanently Disabled or Slain NC FOP Members

Every year the NC Fraternal Order of Police Foundation, Inc. awards scholarships to children of NCFOP members in good standing who have been killed or permanently disabled in the line duty. Four \$500 scholarships are also awarded to children of NCFOP members in Good Standing.

To apply for a scholarship, you can visit ncfop.org under the About Section and click on Foundation. There you will find the scholarship application to download and complete. Once the application is completed email it to Foundation President Greg Brown at brown\_bg@earthlink.net. or mail the completed application to

NCFOP State Lodge Care of: NCFOP Foundation, Inc. PO Box 6335 Asheville, NC 28816

The following criteria must be met for those applying for a scholarship:

Section 1. Applicants must be a child of an Active NCFOP member that has been killed or permanently disabled in the line of duty.

Section 2. Applicants must be a child, who has taken residency in North Carolina, of an Active FOP member in Good Standing who has been killed or permanently disabled in the line of duty. Section 3. Applicant must be a child of an Active NCFOP member in Good Standing. Four \$500 scholarships will be awarded each year for those approved in this section by the Foundation Board of Directors.

Scholarship amounts and approval will be determined by the Foundation Board of Directors for sections one and two.

#### DID YOU KNOW?

Under North Carolina law, UNC System institutions and North Carolina Community Colleges shall permit certain individuals to attend classes for credit or noncredit purposes without paying the required tuition. The individuals eligible for this tuition waiver include survivors (including children) of a law enforcement officer killed as a direct result of a traumatic injury sustained in the line of duty, and children (between ages 17 and 23 years of age) whose parent is a law enforcement officer who is permanently and totally disabled as a direct result of a traumatic injury sustained in the line of duty. Please review Chapter 115B of the North Carolina General Statutes for further details.

The primary purpose of the North Carolina Fraternal Order of Police, Inc., is to exist as a benevolent foundation for the purpose of assisting children of North Carolina Fraternal Order of Police Active Members in Good Standing, who have been killed or permanently disabled while in the line of duty, with the expense of higher education. The awarding of scholarships is determined by the North Fraternal Order of Police Foundation, Inc., Board of Directors.

Besides benefiting the children with scholarships, there is also a benefit to the contributor. The North Carolina Fraternal Order of Police Foundation, Inc., is a 501C-3 charitable corporation and all donations are tax deductible. We do not use professional telemarking services, therefore, all funds donated come directly to the Foundation and your financial donations are perpetual. This means that your donation remains in the Foundation forever and only the earnings from your original donation are used to fund the scholarships.

#### **Thank You West Chester Ohio FOP Lodge 186**

The fraternalism of the FOP was on display long after Hurricane Helene devasted parts of the southeastern United States and western North Carolina. Our brothers and sisters from West Chester (Ohio) FOP Lodge #186 stepped in to help in a big way.

On November 29, 2024, a caravan of trucks, trailers, and police cars arrived in Marion, North Carolina from West Chester, Ohio to deliver five (5) Ford Explorer police vehicles for western North Carolina towns. The cars were going to police departments which were greatly affected by Hurricane Helene. After contacting NCFOP State President, Chet Effer and the State Trustee from our Asheville Lodge, Jimmy Wingo we were able to determine the need for the cars was great. President Effler and State Trustee Wingo were able to identify four police agencies that badly needed the assistance. The police departments that stepped up and accepted the gift from West Chester, Ohio were Old Fort, Black Mountain, Montreat College, and Spruce Pine.



I was contacted in late October by Brent Lovell of the West Chester Township FOP Lodge #186 about his Lodge and the town of West Chester, Ohio wanting to partner to assist North Carolina communities that were badly affected by Hurricane Helene. West Chester was in the process of rotating five Ford Explorer vehicles out of police service. Rather than selling them at auction they decided to donate them to police departments in North Carolina that needed some assistance. After several phone calls and texts with the leadership of the West Chester FOP Lodge #186, on November 29, 2024 the cars arrived in Marion, North Carolina for the agencies to deliver the tremendous gift from our neighbors to the north in Ohio. Representatives from the NCFOP, as well as the towns of Old Fort, Black Mountain, Spruce Pine, and Montreat College, were on hand as the three trucks with trailers rolled into the Marion Police Dept. to make the delivery. Brent Lovell who is with the West Chester FOP and also an officer in the township police department, along with several other officers and FOP members, accompanied the vehicles as they were delivered. While the cars were donated by West Chester Township, the cost of having the cars delivered was taken care of by the West Chester FOP Lodge #186. The vehicles were in excellent condition and all with less than 80,000 miles. Each car had been given a tune-up, new tires, and a full tank of gasoline before delivery. The police cars had all the emergency equipment (lights and sirens) still installed and working. They were also equipped with radar units for speed enforcement with front and rear-facing antennas and a lock box in the rear area for securing additional firearms. Each police vehicle was full of clothing and toys for the folks in western North Carolina. To say everyone there was shocked by the condition of the cars and how they were ready for immediate police service would be an understatement.



As the cars were unloaded and the departments selected the vehicle they wanted, we talked with the members of the West Chester FOP Lodge about how much we appreciated the thought that went into making this happen. We thanked them for their efforts as well as the extremely kind gesture of the West Chester Township which had decided to allow the cars to be donated rather than sold.

This type of response is what separates the FOP from other law enforcement organizations. Brothers and Sisters are willing to step up and offer any type of assistance needed during tough times. With 377,000 FOP members across the country, we would just like to say thank you to the West Chester FOP Lodge #186.

As we wrap up the holiday festivities and settle into 2025 (and remembering to write 2025 on various items and documents) we turn our attention to a new year of Compliance.

Hopefully, as you are reading this, you or someone from your Lodge is preparing to send your 2024 Lodge Minutes to your member of the Constitution & By-laws Committee. As soon as the Minutes of your last 2024 meeting are approved, send them in to the committee. These Minutes are due to the assigned Committee contact by February 28, 2025.

The new year also means tax time for many of our Lodges. As a reminder, your 990 (either e-postcard or long form) must be submitted by the fifteenth day of the fifth month following your fiscal year end. For those Lodges whose year ended December 31st, your taxes must be filed by May 15, unless you file an extension. The Committee must have documentation of either your tax filing or your extension to consider your Lodge to be in Compliance.

As several Lodges found out during our 2024 Biennial Conference, compliance is required to have voice or vote at either conferences or meetings of the State Board of Directors. If you have a compliance question or issue, please reach out to either myself, or a member of the committee.

This year is also a great time to review your Lodge's Constitution & By-laws. As a reminder, any amendment approved by either the National or State Fraternal Order of Police does not require approval of the State Board of Director to add to your Lodge's Constitution & By-laws.
